PART A

CASE STUDY - COMPULSORY

QUESTION ONE

The following are **FOUR** scenarios. State whether the various contracts are frustrated and **BRIEFLY** explain why.

- a. Oliver agreed to build 3 houses for Elizabeth within one year for a fixed price. Due to bad weather, and a shortage of labour in the construction industry, the work took two years and cost GHS30,000 more than was anticipated by the contract. Oliver contends that the contract is frustrated. **[10 MARKS]**
- b. Cindy has agreed to supply Abena with 100 boxes of yam. However, there is a turn of events which they did not at both anticipate a wholly abnormal rise in the prices of yam due to increases in production costs, such as fertilizer and labour. In addition, there is a sudden depreciation of the Ghana Cedi. Cindy refuses to supply the goods, insisting rather innocently, that her lawyers have informed her that the contract is frustrated. [10 MARKS]
- c. Emerald is an up-and-coming Reggae artiste who needs someone to manage her career. She is introduced to Mr. Boakye, a well-known songwriter and record producer. Emerald employs Mr. Boakye as her manager for seven years. After one year, Mr. Boakye was imprisoned for a term of 5 years for shooting a friend. On his release from prison, Mr. Boakye sued Emerald for certain breaches of the agreement and Emerald is alleging that by reason of Mr. Boakye's crime, the management contract was frustrated. [10 MARKS]
- d. Grace has ordered firecrackers and Carlo Rossi wine from Pablo Limited to be delivered from Mexico on 5th October 2023. On 1st October 2023, the government passed a law making the importation of firecrackers into Ghana illegal. Also, Pablo Limited is prevented by the Food and Drugs Authority (FDA) from supplying Grace with the wine because it failed to obtain the required permit to sell Carlo Rossi wine. Pablo limited says the contracts are frustrated.
